The Intellectual Property Policy of the University indicates clearly that teaching materials are owned by their authors, subject to some rights for the University to use them for the purpose of teaching. The consequence of that rule is that professors and lecturers are responsible or the enforcement of their intellectual property ights.

However, the University has and will continue to take measure so limit infringement of the IP rights of its instructors. The issue is complex, because require so alancing the rights of instructors to protect their intellectual property with those of students who should have easy access to the materials they need to learn. Among the measure implemented to date are the:

- Adoption of myCourses, where access to course material is restricted to students registered in a course. Prior to the implementation of this tool, instructors were often uploading their course material on the internet.
